Problem Statement

Solution Offered

- ★ Regulatory Update Notifications – Real-time alerts for regulation rollouts or updates.

Solution : Automated lifecycle management with periodic check-ins, alerts, and dedicated caregiver portals.

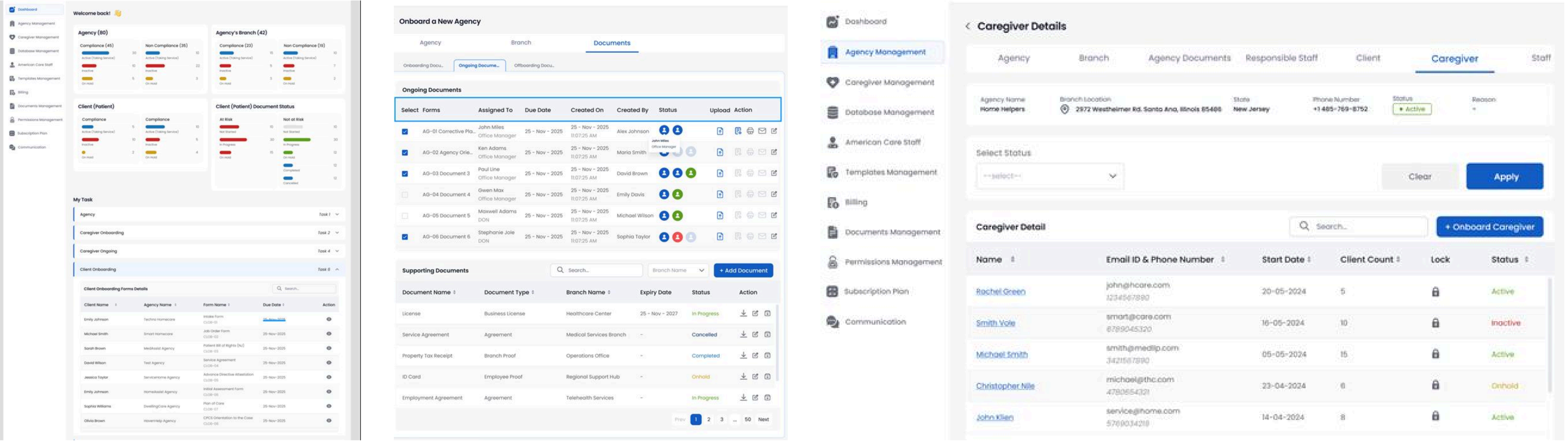
Challenge : Manual Form & Documentation Burden
